

The Cost of Attendance is an estimate of a student's average educational expenses for the period of enrollment. The Cost of Attendance doesn't only include tuition; it also takes basic living expenses into account. Cost of Attendance is made up of two different types of costs: direct and indirect.

Direct costs are items that are billed by West-MEC, such as program tuition & fees and books & supplies.

Indirect costs will not appear on your bill but are estimated costs associated with going to school and should be included in your budget. These include items like living expenses, transportation, and personal expenses. These amounts are based on a periodic survey of current students.

Tuition & Fees:

Tuition: \$7.25 per clock hour (for programs starting 1/1/2024 through 12/31/2024)

\$8.25 per clock hour (for programs starting on or after 1/1/2025)

Lab/supplies fees: varies by program

Admission fee: \$150 (for programs starting after 1/1/2024)

Administrative fee: \$100 (for programs starting after 1/1/2024)

Books, course materials, supplies, and equipment: varies by program

Living Expenses, including housing & food: calculated based on length of program.

Off-Campus: \$372/week

With Parent: \$85/week

Transportation: calculated based on length of program.
